

# MINNESOTA WRESTLING COACHES ASSOCIATION

## DAVE BARTELMA WRESTLING HALL OF FAME

To be considered for induction into the Dave Bartelma Wrestling Hall of Fame, an individual's qualifications must first fall within the following conditions:

### CATEGORIES:

- A. Coach
- B. Contributor
- C. Wrestler

A person may be presented for membership in any of these categories. He/She may qualify for more than one category, which of course makes it more desirable.

### CRITERIA:

#### A. Coach

1. Ten years as a wrestling coach in Minnesota. Time as an assistant coach will count towards ten (10) years.
2. Must have or had a winning record. **If no record is shown, the candidate will not be considered until correct record is provided.**

#### B. Contributor (could be a combination of:)

1. Assistant Coach
2. Official
3. Wrestling Club work
4. Media
5. Individual Merit
6. The contributor must have been active in his/her area for a minimum of ten (10) years

#### C. Wrestler

Must have been out of high school at least nine (9) years or college competition for at least five (5) years.

#### D. Moral Character

All candidates shall represent good moral character in society.

#### E. Maximum Number of Inductees Per Year

The maximum number of individuals to be inducted in any year will be eight (8).

#### F. Voting

The Hall of Fame Selection Committee will select the Inductees from the candidates submitted by the deadline. A candidate must receive 67% of the votes cast to be elected into the Dave Bartelma Wrestling Hall of Fame.

#### G. Eligible

All applications will be considered for five years. If after five years the candidate has not been selected, the application will no longer be considered. A new application will need to be presented to re-activate the candidate.

The above criteria will be used by the Selection Committee. When completing nomination application, be sure you include all pertinent information. This will aid the selection committee to insure more accuracy.

- **Please restrict the number of letters of support to six (6) other than the application.**
